**CPC Announces Plan to Build New, Larger U.S. Manufacturing Facility and Redundant Cleanroom**

*Dear Distributor Partner,*

With your support and sales success CPC is experiencing significant growth. To accommodate that growth and to provide redundant manufacturing cleanroom space we are building a new, larger facility.

We intend to transfer manufacturing operations from our headquarters at 1001 Westgate Drive in St. Paul, Minn., to a new facility in nearby Roseville, Minn. After the transfer is complete we will vacate the Westgate facility. Our current cleanroom operations at the Malcolm Avenue facility will continue to operate without change. The new Roseville facility will contain Class VII cleanroom space as additional capacity and redundant cleanroom manufacturing.

The new headquarters and facility will significantly increase our manufacturing space. We are expanding cleanroom operations, the production floor, shipping capacity, and training space. Initial plans are for the new site to be fully validated and operational by the end of June 2020, including certifications to ISO 9001 and 13485 quality system requirements. The new Class VII cleanroom space will meet the requirements of international standards ISO 14644 and ISO 14698.

We are in the planning stages today. As details are set and we identify products whose production processes will be moved, we will provide additional communications. If you have customers whose requirements dictate a notice for changes in production or process, please share this information with them.
